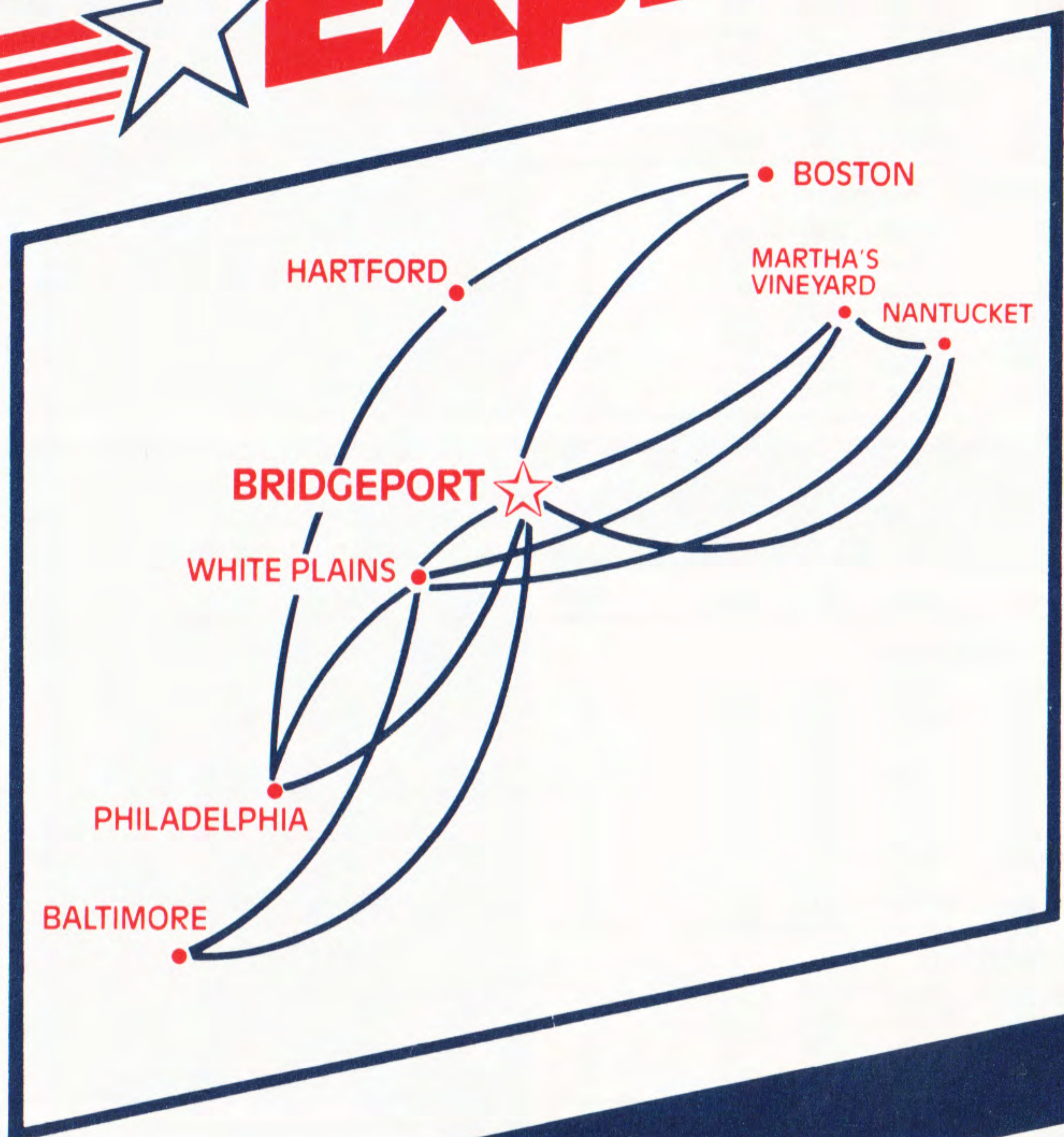

PASSENGER INFORMATION

RESERVATIONS Monday through Friday, reservations may be made between the hours of 6:00 am and 11:00 pm, weekend hours are 8:00 am to 8:00 pm. Call 203-386-9000 or Toll Free 1-800-243-9830.

BAGGAGE Maximum baggage allowance is two pieces with a total weight not to exceed 35 pounds. There is a charge of \$5.00 per bag over the limit, and excess baggage will be carried, space permitting. Maximum baggage liability is \$1,250 per passenger, and no additional coverage is available. Articles such as flammable liquids, corrosives, compressed gases, poisons, explosives, or any other restricted article listed in CFR-49 will not be accepted for carriage. Fragile items, jewelry, medicines, tools, photo equipment, currency, and other such items should not be included in checked baggage.

CHECK-IN All passengers are requested to check in at least 20 minutes prior to scheduled departure time. Business Express reserves the right to cancel reservations of passengers who have not checked in ten minutes prior to scheduled departure time.

RENTAL CARS Rental Cars are available at all Business Express locations.

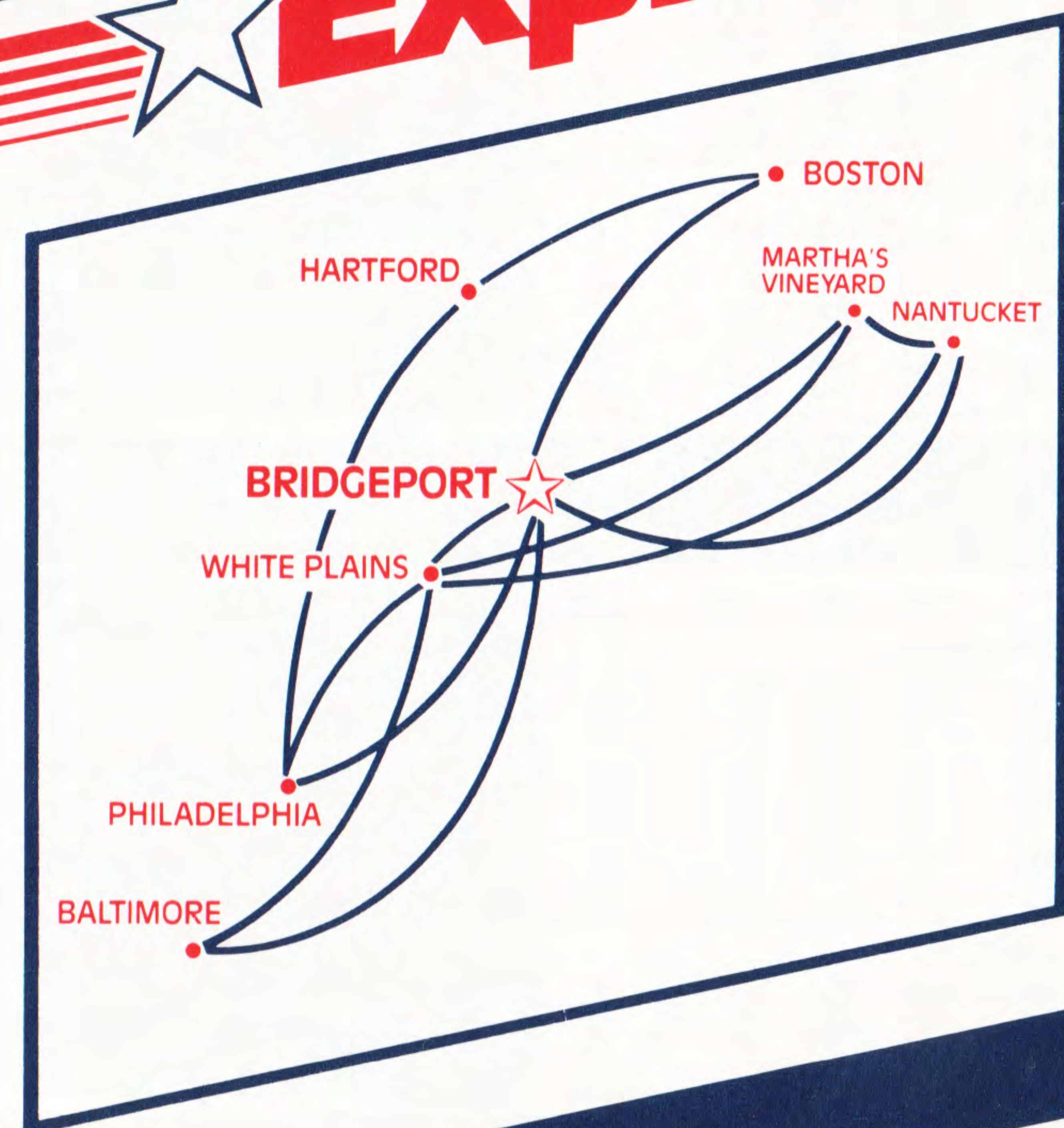
PLEASE DON'T BE A "NO SHOW"
