### Tariff Regulations and General Information

#### RESERVATIONS:

Tickets are not good for passage until reservations are endorsed thereon and then only on day and trip specified. Reservations may be made at any of the ticket offices listed in this folder, ticket offices of other Air Lines, Western Union Telegraph offices and leading hotels and travel bureaus.

#### CANCELLATIONS:

Century Air Lines, Inc., reserves the right to cancel without advance notice any scheduled trip or reservation on account of adverse weather conditions or other causes, and for so doing, shall be under no obligations to ticket holders except to refund, through regular channels, the price paid for said tickets. After the commencement of any flight, the airplane may be landed and passengers discharged in such manner and place as the pilot, in his sole discretion, shall see fit and in the event of such landing at a place other than the destination for which tickets have been sold, the only responsibility of the com, any shall be to refund to ticket holders such proportion of the price paid for each ticket as the distance between the place of landing and destination bears to the whole length of the flight, for which such ticket was issued.

#### REFUNDS:

Passengers may cancel reservations and secure refunds only upon surrender of tickets two hours prior to the scheduled departure of the airplane for which reservations have been made. Such cancellations may be made and refunds obtained at any of the ticket offices listed in this folder or at the office of the Ticket Auditor, Century Air Lines, Inc., 5032 West 63rd Street, Chicago, Illinois.

#### BAGGAGE:

Passenger's hand baggage weighing not in excess of twenty-five pounds must be checked and will be carried free upon condition that company's liability for loss, damage or delay in the transportation of same is limited to \$25.00. Baggage weighing in excess of 25 pounds or valued at more than \$25.00, carried only at company's option and subject to plane capacity and upon payment of additional charges therefor prior to commencement of trip.

#### DELAYS:

The hours of arrival at destination and time consumed on specified trips are not guaranteed by Century Air Lines, Inc., inasmuch as the flight of airplanes is subject to delays from weather conditions and other causes wholly beyond their control. All tickets are sold with the understanding that the company assumes no responsibility for the failure of its airplanes to arrive at any destination as scheduled, or for the failure of any passenger to make connections at destination with any connecting carrier or air line.

#### ROUND TRIP FARES:

Ten per cent reduction from the sum of one way fares will be allowed on round-trip tickets. Return portion of round-trip ticket will not be good for passage until reservation has been made and space assigned.
