





PASSENGER INFORMATION

RESERVATIONS: Passengers holding confirmed reservations on Cochise Airlines must check in at the counter at least 20 minutes prior to departure or their reservations are subject to cancellation.

CHILDREN: Children under 2 years of age travel free of charge when not occupying a seat. Children 2 years old but under 12 years of age travel for 66 2/3% the full fare when accompanied by an adult. Children 8 years of age but under 12 years unaccompanied, pay full fare. Children under 8 years unaccompanied are not acceptable for travel.

BAGGAGE ALLOWANCE: Maximum free allowance is a total of 3 pieces of luggage. Excess baggage charge is \$5.00 per piece. Maximum declared value on luggage is \$750.00 per piece.

REFUNDS: Any refund applied for on the same day as ticket purchase will be processed at that time. Any refund applied for after the day of purchase must be processed through Cochise Airlines Refund Accounting Office. An approximate time of 4 to 6 weeks can be expected to process all refunds. ANIMALS: Animals are accepted for transportation subject to tariff rules. They will be transported in the cargo compartment of the aircraft only. The charge for animals is three (3) times the normal excess baggage rate.

CREDIT CARD ACCEPTANCE: Air Travel Card (UATP), Master Charge, Visa, American Express.



AIR FREIGHT INFORMATION

GENERAL: Cochise Airlines has air freight transportation capability throughout the United States. For air freight information please contact the local air freight telephone number in each city.

RATES: The minimum charge for an air freight shipment is \$20.00 online. Larger shipments are determined at a reduced rate for each 100 pounds.

DECLARED VALUE: All shipments are declared free allowance of \$50.00 per shipment. The charge for excess declaration is 40¢ per \$100.00 or fraction thereof declared.

ANIMALS: Animals are accepted for transportation subject to tariff regulations. The charge is 175% of the normal freight rate. An animal under 8 weeks of age is not acceptable for transportation.

STRAIGHT ARROW PACKAGE SERVICE: Counter to Counter Guaranteed Air Freight Service is available on Cochise Airlines. The maximum allowable weight is 50 pounds per shipment at a rate of \$30.00 plus tax.
