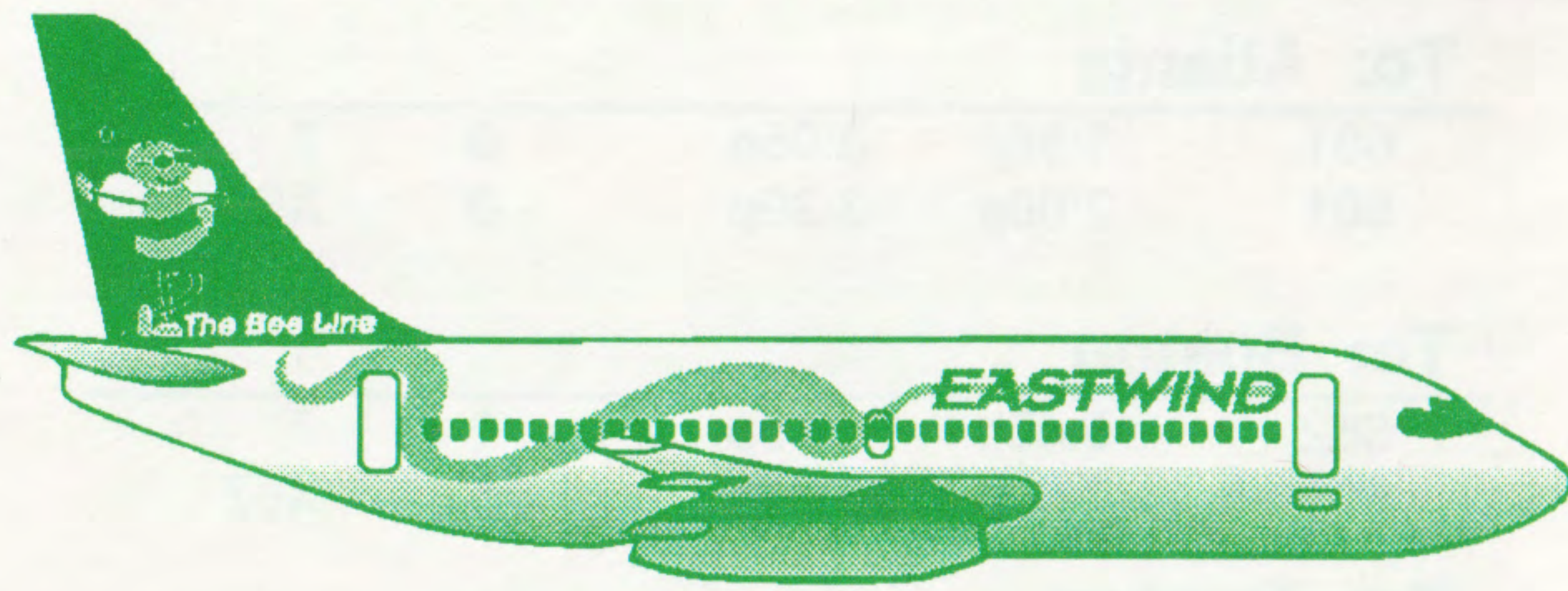

Eastwind Locations:

- Atlanta:** Check-in at AGI ticket counter next to Delta in south terminal; gate in Concourse D.
- Boston:** Check-in at ticket counter next to USAir Shuttle; gate in Terminal A.
- Greensboro:** Check-in at ticket counter next to Continental; gate in Main Terminal.
- Orlando:** Check-in at United Airlines ticket counter; gate in Terminal B.
- Richmond:** Check-in at Continental ticket counter; gate in Main Terminal.
- Trenton:** Check-in at Eastwind ticket counter; gate in Main Terminal.

Contract Terms: Transportation on Eastwind Airlines is subject to the terms of our contract of carriage (Terms of Transportation), which may be inspected at any Eastwind airport location.

Credit Cards: Eastwind Airlines accepts American Express, Master Card and Visa. Personal checks made payable to Eastwind Airlines accompanied by photo identification for the exact amount of the purchase.

Customer Check-In Procedures: Eastwind Airlines is a ticketless airline. Customers must provide a confirmation number and personal photo identification at the time of check-in at the ticket counter and/or gate. Customers presenting themselves at the boarding gate less than 15 minutes before scheduled departure of the flight may lose their reservations and will not be eligible for denied boarding compensation.

Security: For your security all customers and their hand-carried items must be inspected in accordance with the government sponsored security program. It is recommended that passengers proceed through the security check point a minimum of 30 minutes prior to departure time.

Hazardous materials: Eastwind transports no hazardous material in its aircraft.

Baggage: Checked baggage should be locked, with identification on the outside and inside of the bag. Specifics regarding size and weight restrictions, excess baggage charges, limits of Eastwind Airlines' liability, transportation of firearms, sports equipment, wheelchairs, fragile items and animals are available through Eastwind's reservation office and Eastwind airport locations.

Carry-On Baggage: Passengers may carry on (1) one bag without charge subject to space limitations and size of the bag.

Holiday Flights: Certain flights may not operate during holiday periods.

Unaccompanied Children: Specific information on the handling of unaccompanied children is available through Eastwind reservations and airport locations.
