### GENERAL PASSENGER INFORMATION

**CHECK IN TIME:** is 20 minutes prior to departure. Reservations not claimed 20 minutes prior to scheduled flight time are subject to cancellation.

**RESPONSIBILITY:** Schedules are subject to change without notice. Jetstream International will not be responsible for damages resulting from failure of flights to depart or arrive at times stated in their timetable, nor for errors herein, nor for failure to make connections with this or any other airline.

**BAGGAGE:** The maximum free baggage allowance is two (2) pieces with total weight not exceeding 66 pounds per fare paying passenger. Extra checked bags or those over the weight limit will be subject to excess baggage charges.

Passenger's name and address must be on the outside of all baggage. Damage to or loss of baggage must be reported to the carrier immediately upon termination of your flight. Liability to personal property including baggage shall not exceed \$1,250.00 per passenger.

Jetstream International is not liable for loss, damage to or delay in delivery of fragile or perishable articles, money, jewelry, silverware, negotiable papers, securities or other valuables, business documents, samples or articles not suitable or suitably packed for transportation in the aircraft, which are included in the passenger's checked baggage whether with or without the knowledge of Jetstream International.

**RESTRICTED ARTICLES:** Baggage may not contain corrosives, explosives, matches, flammable liquids or compressed gases. Electronic devices must not be used on board aircraft.

**SECURITY:** For security reasons, all unchecked articles carried in the cabin are subject to search. We reserve the right to deny boardings for passenger safety and security.

**NO SMOKING:** Smoking is not allowed aboard Jetstream International aircraft.

**HOLIDAYS:** On national holidays, most Jetstream Int'l flights do not operate on business day schedules. For specific information call Jetstream Int'l Airlines Reservations.
