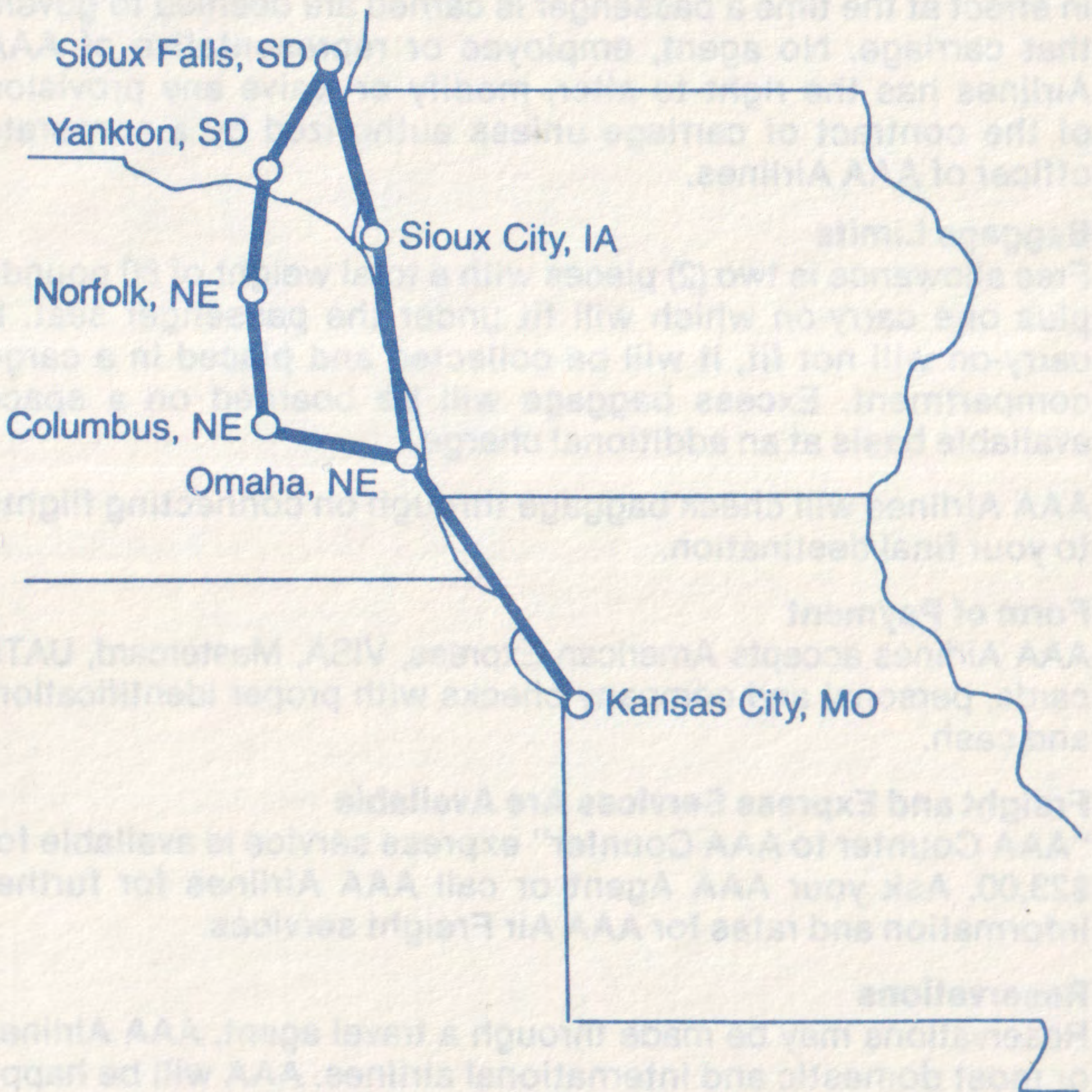

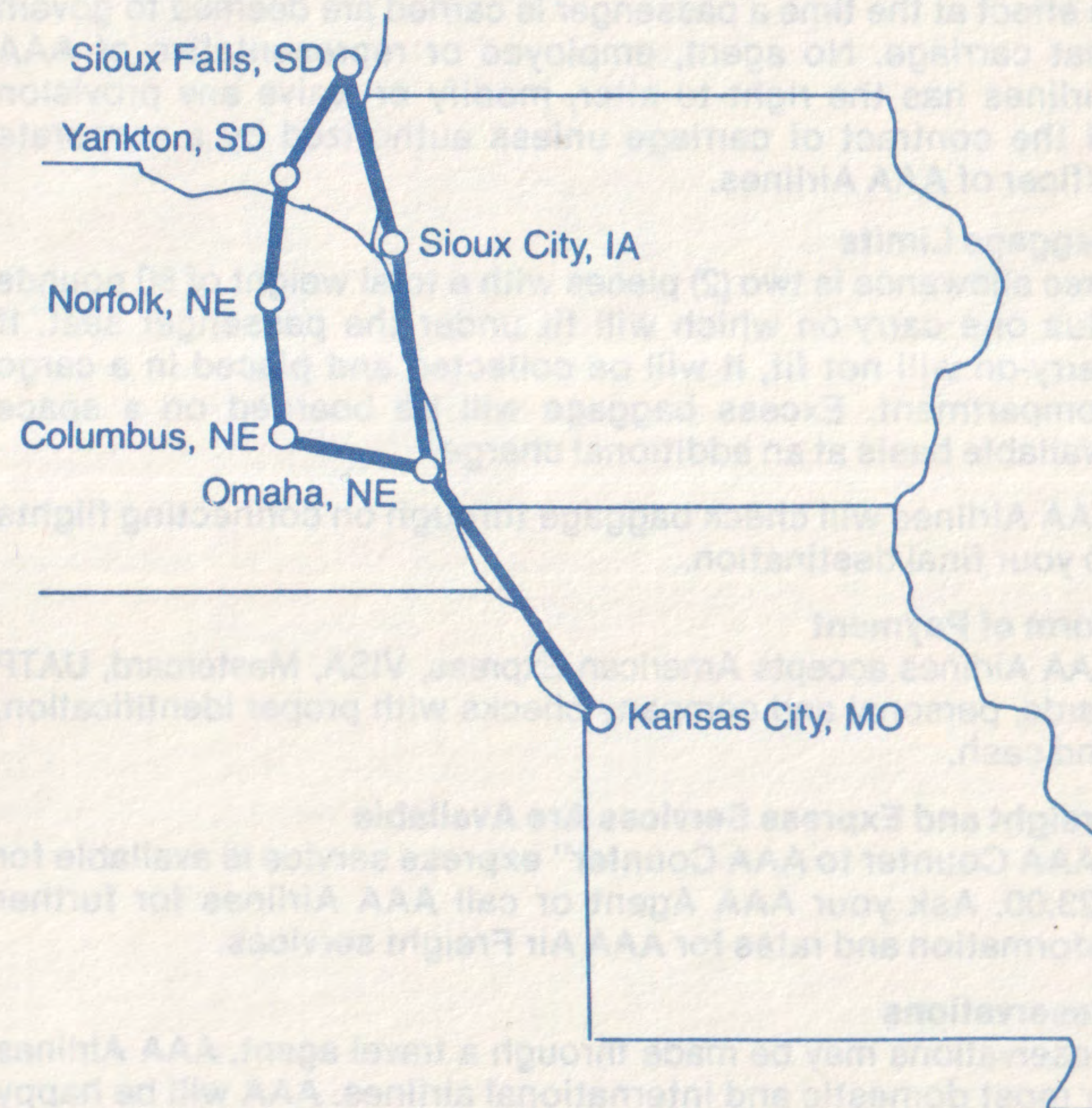

If after examining these Conditions, you are not willing to accept the terms therein, you may apply for a full refund of your fare at any AAA ticket counter.

When you purchased your ticket, AAA Airlines became obligated to provide transportation under specific Conditions of Carriage. Below is a summary of these Conditions of Carriage. A copy of AAA Airlines complete Conditions of Carriage document is available on request at all AAA Airlines ticket counters or by writing to AAA Airlines, P.O. Box 19086, Omaha, Nebraska 68119. Acceptance of transportation on AAA Airlines constitutes acceptance of the terms of AAA Airlines Contract of Carriage.

Check-In Time and Passenger Acceptance Conditions

If you need to be ticketed, please be at the AAA ticket counter 45 minutes prior to flight time. If you already have a ticket, please check in 30 minutes before flight time. Passengers who have not checked in at least 10 minutes before scheduled departure are subject to cancellation.

AAA may refuse to carry passengers (i) who will not permit a search of person or property, (ii) who will not produce positive identification on request, (iii) who are disorderly, intoxicated, improperly clothed, or attempt to interfere with the flight crew. AAA may also refuse to carry passengers whose mental or physical condition would render them unable to provide for themselves in flight, unless accompanied by a responsible adult. A reservation does not guarantee a passenger transportation on AAA Airlines.

The fare in effect at the time of ticket purchase is considered the applicable fare for carriage of the passenger.

Responsibility for Departure/Arrival Time, Connections, Cancelled Flights, and Changes of Service

AAA Airlines makes every effort to operate on time and to carry passengers and baggage with reasonable dispatch consistent with safety. Because weather and other conditions may affect operations, AAA Airlines will not be responsible for damages resulting from failure to depart or arrive at times shown in timetables or elsewhere, for failure to make connections, for changes of schedule for any flight, nor for cancellations of flights. Schedules and fares are subject to change without notice to passengers. AAA assumes no responsibility for the effects of such action. AAA may, without notice, substitute alternate carriers or aircraft and, if necessary, may alter or omit stopping places shown on the ticket. Under no circumstances shall AAA be responsible for special or consequential damages.

In the event of a delay, change, or cancellation, AAA will use its best efforts to make alternate arrangements to accommodate passengers to their final destinations.

Overbooking

AAA sometimes sells more tickets for a flight than there are seats for such a flight. If this occurs, AAA does not guarantee carriage to any passenger regardless of check in or payment of fare. AAA will provide Denied Boarding Compensation including an immediate refund check for the amount of the passenger's fare in such cases.

Baggage Liability and Excess Valuation Charges

Liability for loss or damage to baggage is limited to \$1,250 unless a higher value is declared and applicable charges paid before departure. Excess valuation coverage is available for an additional charge of \$1.00 per each \$100.00. Maximum valuation is limited to \$5,000. AAA assumes no liability for perishable goods, fragile items, or improperly packed items, whether carried with or without the knowledge of AAA Airlines.

Limits of Liability

For domestic travel, AAA Airlines limits its liability for personal injury or death to \$300,000. AAA limits its liability in international travel to \$75,000 in accordance with the Warsaw Convention.

Claims Restrictions

Written notice of all claims must be given to AAA Airlines within twenty-one (21) days of the incident and any legal action must commence within one year.

Right to Change Conditions of Carriage

AAA Airlines reserves the right to modify or change its terms and conditions at any time. The terms and conditions of carriage in effect at the time a passenger is carried are deemed to govern that carriage. No agent, employee or representative of AAA Airlines has the right to alter, modify or waive any provision of the contract of carriage unless authorized by a corporate officer of AAA Airlines.

Baggage Limits

Free allowance is two (2) pieces with a total weight of 80 pounds plus one carry-on which will fit under the passenger seat. If carry-on will not fit, it will be collected and placed in a cargo compartment. Excess baggage will be boarded on a space available basis at an additional charge.

AAA Airlines will check baggage through on connecting flights to your final destination.

Form of Payment

AAA Airlines accepts American Express, VISA, Mastercard, UATP cards, personal and company checks with proper identification, and cash.

Freight and Express Services Are Available

"AAA Counter to AAA Counter" express service is available for \$23.00. Ask your AAA Agent or call AAA Airlines for further information and rates for AAA Air Freight services.

Reservations

Reservations may be made through a travel agent, AAA Airlines or most domestic and international airlines. AAA will be happy to make reservations for your entire trip including any connecting flights.

Ticket Refund

Tickets purchased from AAA may be mailed to the corporate office for a refund or a refund application may be submitted at any AAA ticket counter. These refunds take about 14 days to process. Tickets purchased from other airlines or travel agents should be refunded by the party from whom the ticket was purchased. AAA will accept refund applications on AAA tickets purchased from other airlines, however, these refunds generally take about 90 days to process.
