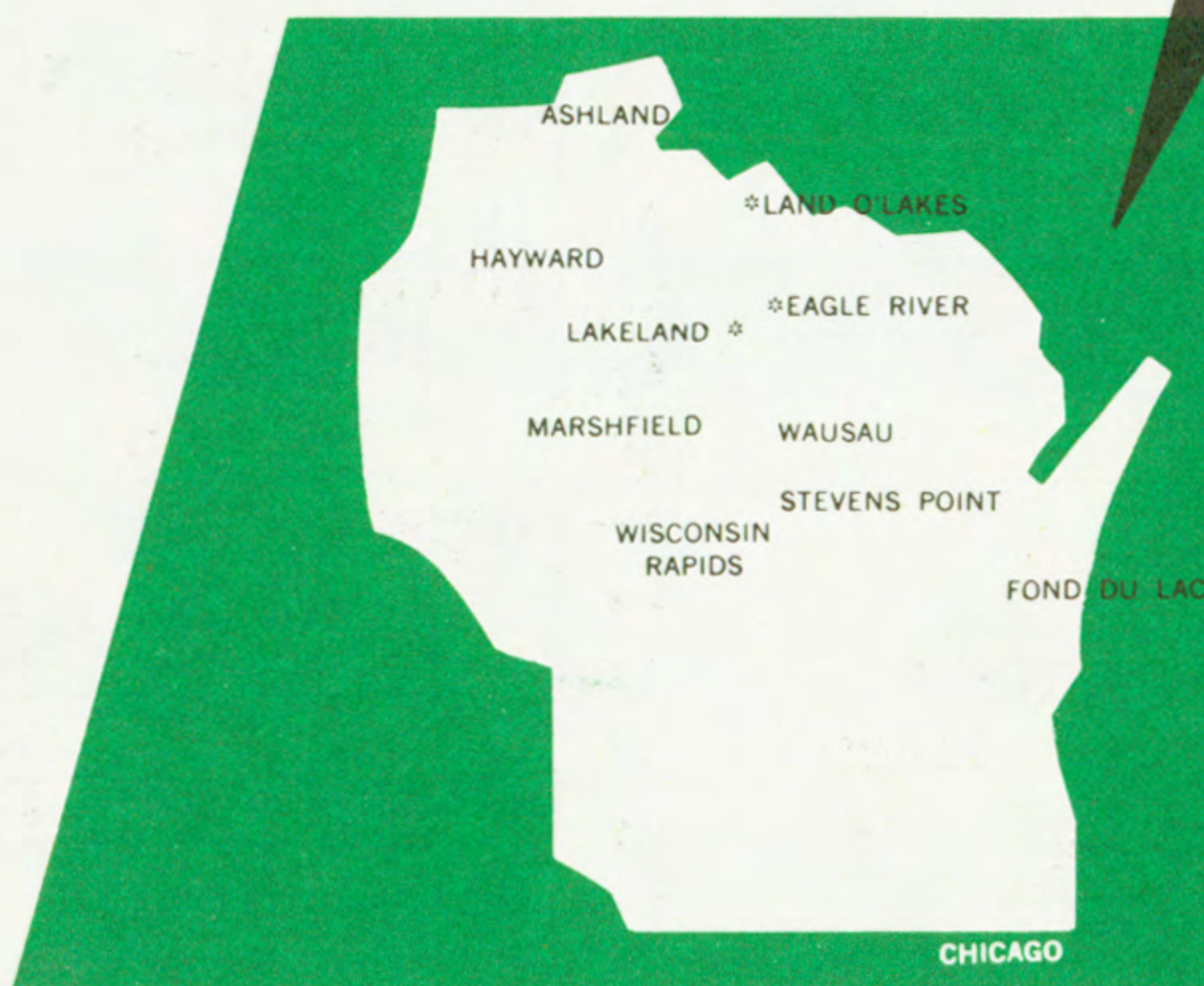

GENERAL INFORMATION

Check In Time: 20 minutes prior to departure.

Insurance: \$100,000.00 per seat, also flight insurance.

Credit Cards: All Major Credit cards accepted as a basis for credit. Billings will be direct.

Baggage: Fifty pounds of baggage including brief case and hand luggage will be carried free on any ticket. Charge for excess baggage will be 10c per pound. Maximum liability per passenger is \$100.00 unless excess valuation is declared and paid for prior to trip departure.

Re-Confirmation: Please re-confirm your reservation after a stopover of more than 12 hours. Re-confirmation is necessary at least 6 hours before departure in order to assure your reservation.

Rental Cars: Available at all stations.

O'Hare Ticket Counter: Midstate operates from the A-Concourse located adjacent to the International Terminal.

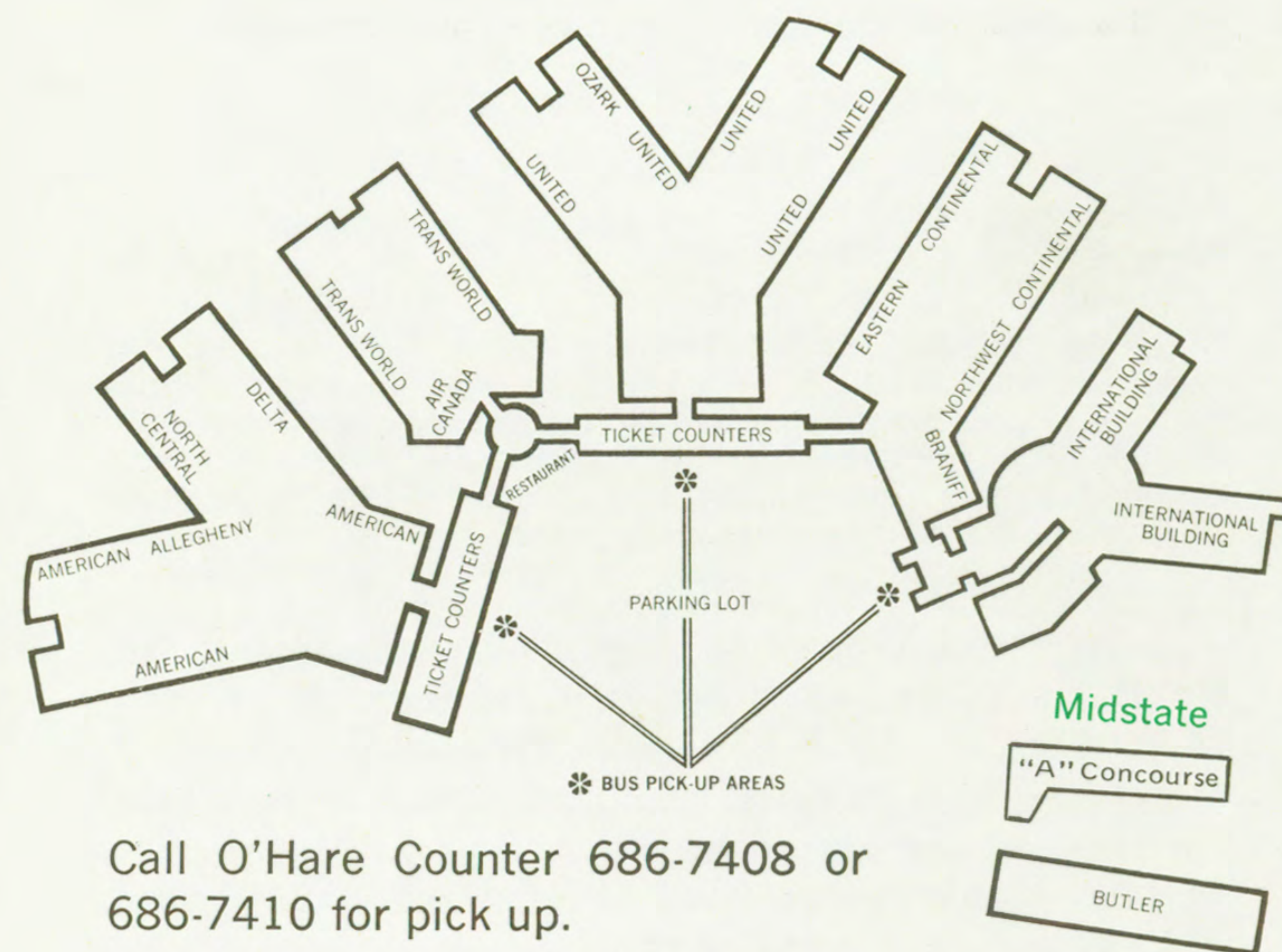

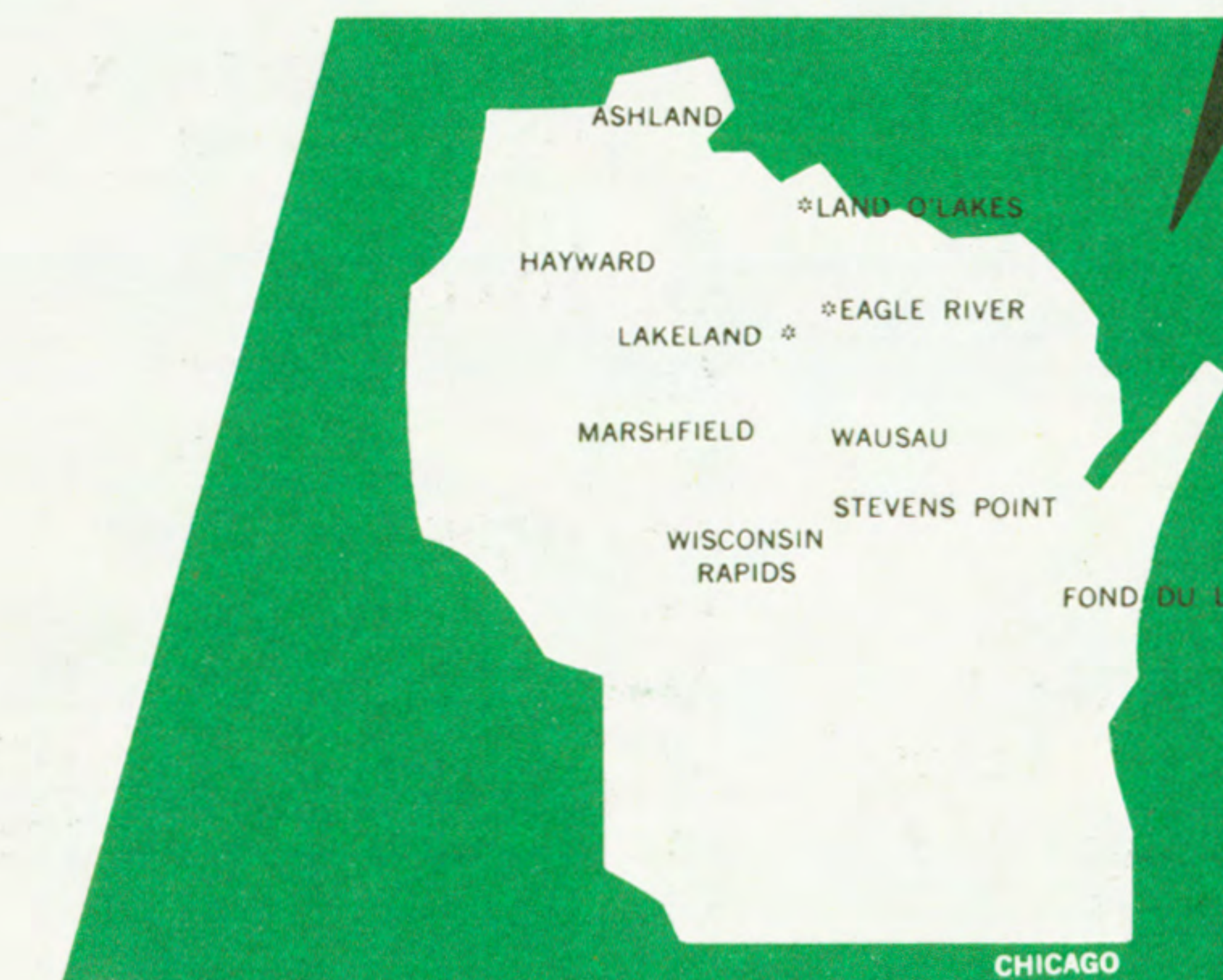

Midstate's 30-Day Round Trip Excursion Fare applies midnight Sunday through Noon Friday and Midnight Friday through Noon Sunday. Travel must be completed not later than Midnight of the 30th day after travel commences from point of origin. Return flight may not commence earlier than 7 days after departure date from point of origin.

SPECIAL DISCOUNT FARES

Family Fares: When one parent purchases a full fare ticket, the other parent and/or child through 21 years of age fly for 75% of regular first class fare.

Children's Fares: Children under 12 years of age travel for 50% off the adult fare. Children under 6 years must be accompanied by an adult and children under 2 years not occupying a seat FREE.

Military Fares: Military reserved seat fare is 75% of the regular first class full fare. Military Standby is available at 50% of the regular first class full fare. (proof of authorized leave required on both reserved seat and standby basis).

Student Fares: 75% of regular first class full fare with Midstate student fare card.

MIDSTATE AIR CARGO SERVICE

Passenger Aircraft: Air freight is accepted on a space available basis. Live animals accepted only after completing prior arrangements. NOTE: For all purposes of this tariff LIVE ANIMALS are defined as: All Mammals (other than humans), birds, fish, crustacea, shell fish, insects, reptiles, worms and amphibia.

Charges for Weight: Transportation charges for Air Cargo will be assessed on which ever is greater, the gross weight of the shipment, or the cubic dimensional weight, measured on the greatest dimensions (Height, Width and Length). Cubic dimensional weight is based one pound for each 250 cubic inches, except 266 cubic inches for cut flowers or nursery stock.

Air Freight Rates: \$7.00 per 100 pounds; \$6.30 per one thousand pounds; minimum per shipment \$9.00.

Excess Valuation Charges: A shipment shall have a declared value of no more than \$50.00 unless a higher value is declared and so indicated on the airbill.

Excess value charges are 20c for each one hundred dollars, or portion thereof of declared value over the free valuation of \$50.00.

Exceptions to General Commodity Rates: Live animals and human remains are charged at 200% of the general commodity rate, i.e., 200% x 7c = 14c per pound or \$14.00 per one hundred pounds. The minimum charge per shipment remains at \$9.00.

Assembly or Distribution Service: Both assembly and distribution service cannot be performed on the same shipment. Written instruction must be given to the carrier not later than receipt of shipments. CHARGES: 50c per addressee; minimum \$2.00. Complete details are available on request from your MIDSTATE AIR COMMUTER agent.

C.O.D. (Collect on Delivery) Shipments: The shipper is solely responsible for entering the amount of the C.O.D. on the airbill, and the carrier shall not be liable for failure to collect the C.O.D. amount when it is not so entered by the shipper. The shipper must also have the letters "C.O.D." and the total amount to be collected on delivery, legibly and durably marked on each piece of C.O.D. shipments. C.O.D. fee 10c per one hundred dollars or portion thereof.

Unusual Shipments: Unusual shipments may require special packaging or are too large and some cannot be accepted. Consult MIDSTATE reservations for information.
