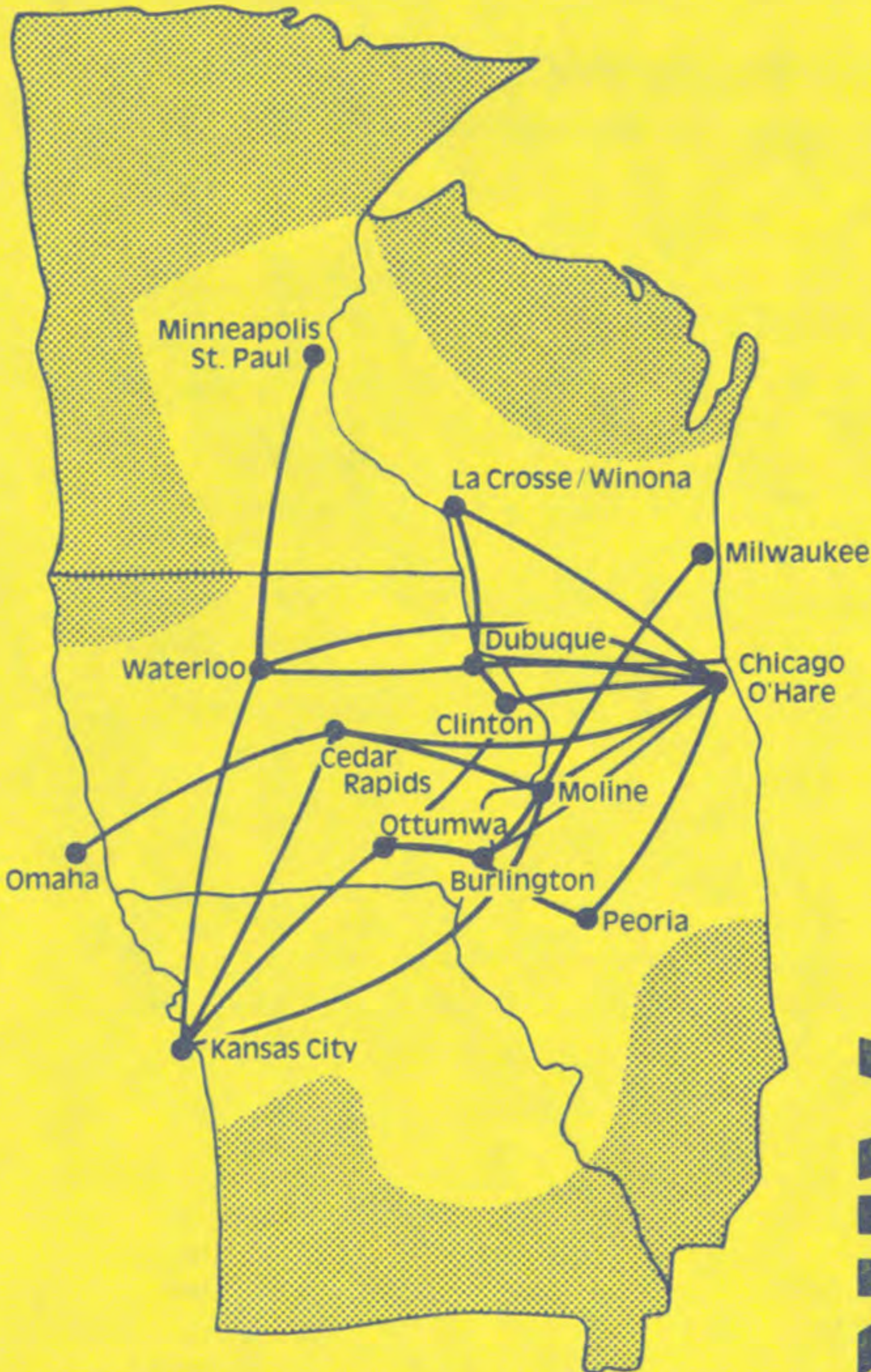

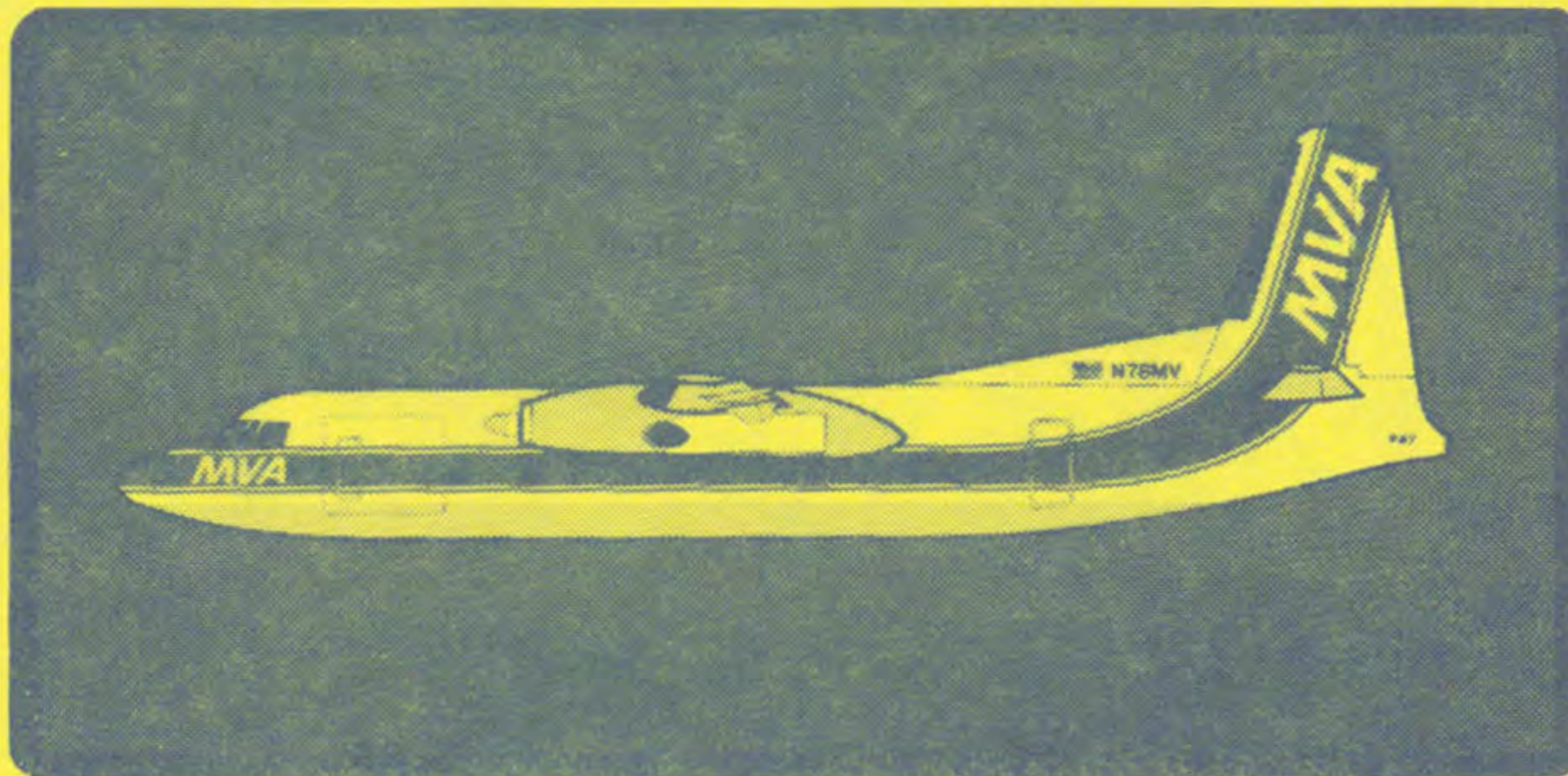

An unexpected delay? A change of plans? Whatever the reason you're unable to use your Mississippi Valley Airlines reservation, please let us know.

The no-show factor approaches 20% on our peak period flights! Please help us reduce it so we can accommodate your travel needs and those of others.

*For better service may we make the following suggestions:*

**Check-in Time for Flights:** For on-time service, we require the following minimum check-in time:  
 Unticketed passengers - 30 minutes  
 Ticketed passengers - 10 minutes

Please check in at the ticket counter at least 20 minutes before flight time. Reservations are subject to cancellation unless you present yourself at the ticket counter at least 10 minutes prior to scheduled departure time. MVA flights may be boarded prior to schedule to insure an on-time departure. Please be available to board at the departure gate 10 minutes prior to scheduled departure.

**Responsibility for Departures, Arrivals, Connections:** Mississippi Valley Airlines will not be responsible for consequential damages resulting from the failure of flights to depart or arrive at times stated in this timetable nor for errors herein, nor for failure to make connections with planes or other airlines or of this company. In case of flight irregularities, certain amenities may be provided in accordance with applicable tariff. Consult an MVA Agent for details.

**Re-confirmation:** Please confirm *return* reservations at the city where you will board at least 6 hours prior to scheduled departure and leave a phone number where you may be reached.

Please cancel your reservation promptly if your plans change or it is evident you will be too late for the flight.

**Carry-on Baggage Regulations:** Carry-on articles such as briefcases, hat boxes, musical instruments, etc., must be limited to a size that can be placed under your seat. Items not meeting this size limitation must be checked as baggage and loaded in that compartment.

**Baggage Identification:** Airline regulations approved by the Civil Aeronautics Board require that all checked baggage must have external identification showing the passenger's name. Baggage identification labels are available at MVA ticket counters.

**Baggage Liability:** The Company's liability for loss or damage to baggage is limited to the amount published in official tariffs (CAB #352 Rule 230 paragraph (A) ). You may declare extra value by paying a nominal charge before departure (Rule 230 paragraph (C) ).

Carrier is not liable for loss, damage to, or delay in the delivery of fragile or perishable articles, money, jewelry, silverware, negotiable papers, securities or other valuables, business documents or samples or articles not suitable or suitably packed for transportation in the aircraft, which are included in the passenger's checked baggage whether with or without the knowledge of the Carrier.

**Restricted Articles:** Articles such as flammable liquids, corrosives, acids, compressed gasses, matches or other hazardous articles must not be placed in baggage. (In addition, Federal Aviation Regulations limit the carriage of compressed gasses in aerosol cans, such as hair

sprays, shaving cream, and deodorants to 32 ounces per passenger with a maximum of 16 ounces per container.) "Visible Fluid" lighters may not be used on board aircraft. AM and FM radios, TV receiver and other electronic devices must not be used on board aircraft in order to avoid disturbance of the aircraft's electronic navigational equipment. Portable electronic devices such as voice recorders, hearing aids, heart pacemakers and electric shavers will be permitted.

**Equipment:** Flight numbers 300 through 499 are scheduled with Shorts SD3-30 thirty passenger aircraft. Flight numbers 20 through 199 are scheduled with Beechcraft B-99 fifteen passenger aircraft. Aircraft type subject to change without notice.

**AIR FREIGHT SERVICES:** Air Freight is carried on all MVA flights. Freight carried on passenger flights is restricted to a maximum weight of 150 pounds per piece without prior notification. Connections are made direct to all carriers.

**PICK-UP AND DELIVERY SERVICE** is available at all points served on MVA's system and at the final destination of the shipment.

**CHARGES** - Shipments can be made prepaid or collect and credit arrangements can be made by contacting your local MVA agent.

**DECLARED VALUE** - You are allowed \$50.00 free valuation on shipments weighing up to 100 pounds and \$.50 per pound on shipments over 100 pounds. If a higher value is declared on the airbill, an additional charge of 40 cents per \$100.00 (or fraction thereof) will be assessed.

**S.P.R.** - MVA's small package service offers you same day service for your urgent and shipping needs. For shipments of 50 pounds and under and no more than 90 inches in girth MVA guarantees it. For additional information and to arrange for pick-up and delivery, call 1-800-638-7346.

MVA will not accept for shipment, materials defined as hazardous materials according to C.A.B. 82 of C.F.R. 49.

**Schedules:** Information shown is subject to change. Please confirm times with MVA reservations. Since holiday schedules may differ, please call MVA reservations for this information. Holidays with schedule adjustments include the weekends of Easter, Memorial Day, Fourth of July, Labor Day, and the holiday periods of Thanksgiving and Christmas/New Years.

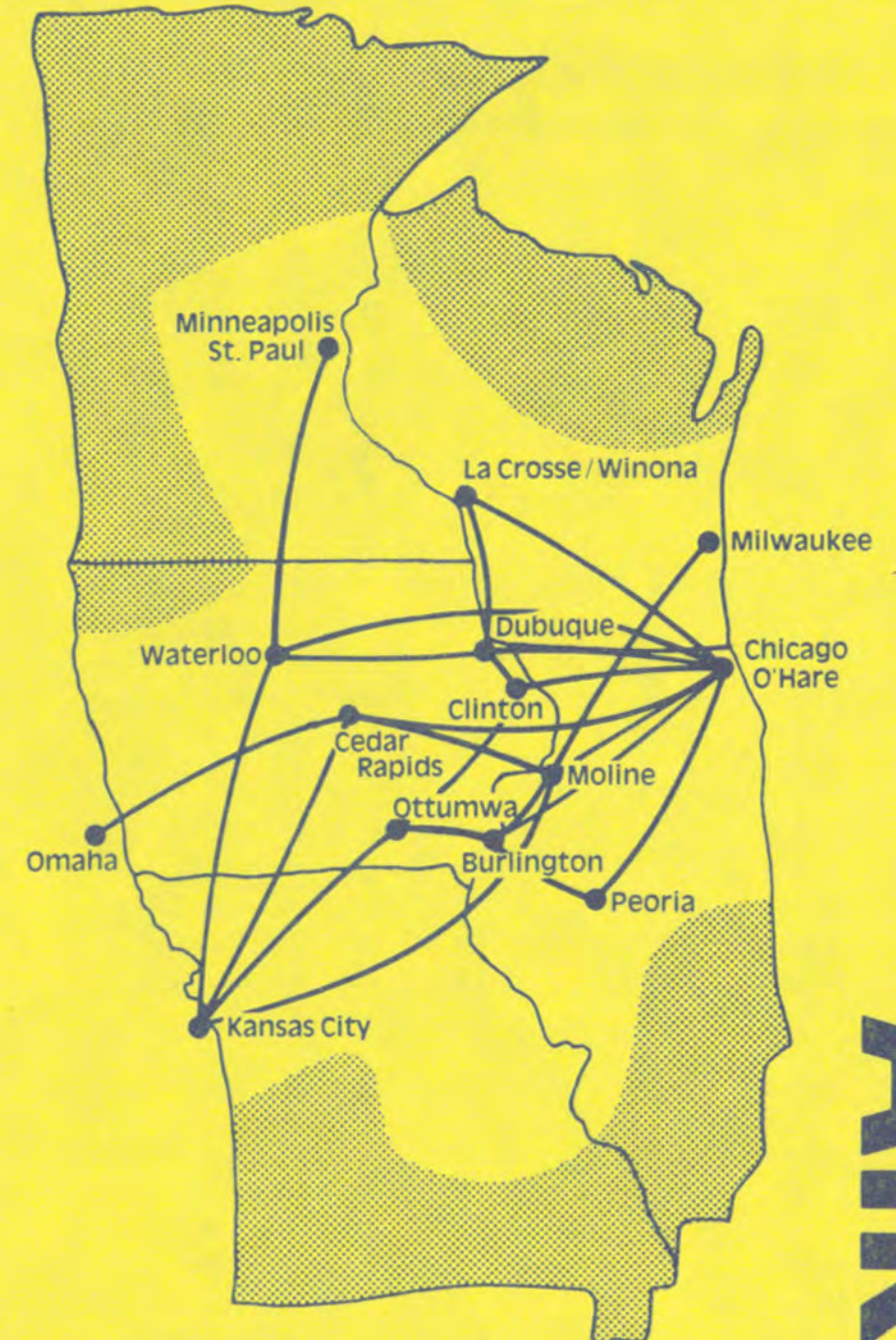
**O'Hare Continuous Courtesy Bus Pick-up**
