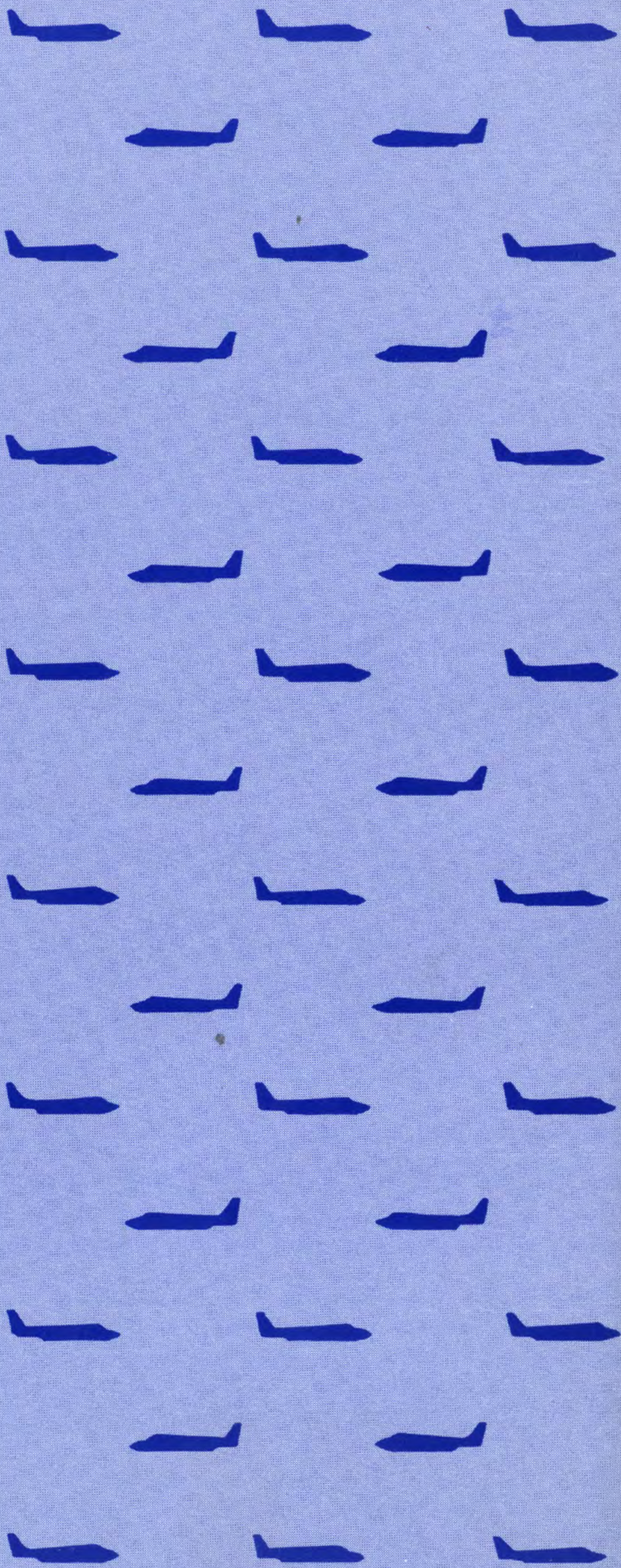

**CHECK-IN FOR FLIGHTS.** In the interest of on time service for all passengers, TCA requests that passengers without tickets be at the airport counter 30 minutes prior to published departure time. Ticketed passengers should be at airport counter 20 minutes prior to the scheduled time of departure. RESERVATIONS OF PASSENGERS PRESENTING THEMSELVES AT THE TCA TICKETLIFT POINT LESS THAN TEN MINUTES BEFORE SCHEDULED DEPARTURE OF A FLIGHT WILL BE SUBJECT TO CANCELLATION.

**BAGGAGE.** The maximum free baggage allowance is two (2) pieces per passenger, with a total weight not to exceed 50 lbs.

**EXCESS BAGGAGE CHARGES.** When the size, weight, or number of pieces exceeds TCA maximum allowance, excess charges of \$8.00 per bag will apply.

**BAGGAGE IDENTIFICATION.** TCA will not accept baggage unless a label or tag with the passenger's name is on the outside.

**BAGGAGE LIABILITY.** TCA's liability for damage to or loss of baggage is limited to \$500.00 per fare-paying passenger unless a higher valuation is declared and additional charges paid in advance. If a higher value is declared over the above limit of liability, the higher value will be assessed at \$1.00 per \$100.00.

TCA is not liable for loss, damage to, or delay in the delivery of fragile or perishable articles, money, jewelry, silverware negotiable papers, securities or other valuables, business documents, or samples, or articles not suitable or suitably packed for transportation in the aircraft, which are included in the passenger's checked baggage with or without the knowledge of the airline.

**CARRY-ON BAGGAGE.** All carry-on baggage must fit under the seat in front of you. The maximum dimensions are a briefcase of 18"x12"x3½". All other items must be checked as "Checked Baggage" or put into the nose compartment of the Metroliner or stored in the carry-on front rack.

**NO SMOKING.** We ask that passengers not smoke on board TCA aircraft.

**HAZARDOUS MATERIALS.** For safety reasons, articles such as flammable liquids, corrosives, compressed gas or matches should not be placed in baggage. Federal Aviation Administration regulations limit the amount of compressed gas in aerosol cans, such as hairspray, shaving cream and deodorant, to a total of 32 ounces per passenger, with a maximum of 16 ounces per container.

**RESPONSIBILITY OF TRANS-CENTRAL AIRLINES.** TCA aims to maintain a high standard of service and the highest standards of safety in serving our customers. TCA will not be responsible for damages resulting from failure to depart or arrive at times stated in this timetable, nor for failure to make connections with other flights. TCA will maintain the right to cancel flights or reservations whenever deemed advisable or necessary for safety, weather, or other reasons. Schedules and fees are subject to change without notice. Since holiday schedules may differ, please call your TCA Reservations Office for this information.

**PLEASE DON'T BE A "NO SHOW"**  
 If you're unable to use your TCA reservation, please let us know. When your plans change or you decide to travel by some other means, we welcome a telephone call so we can make a confirmed seat available for someone else to travel. The no-show percentage approaches 30 percent on TCA's peakperiod flights. Often many of our customers who need confirmed seats cannot be accommodated because of reserved space that will not be used. So please call any TCA reservations number and let us know. You'll be helping your fellow travelers and you'll be helping TCA to serve you better.

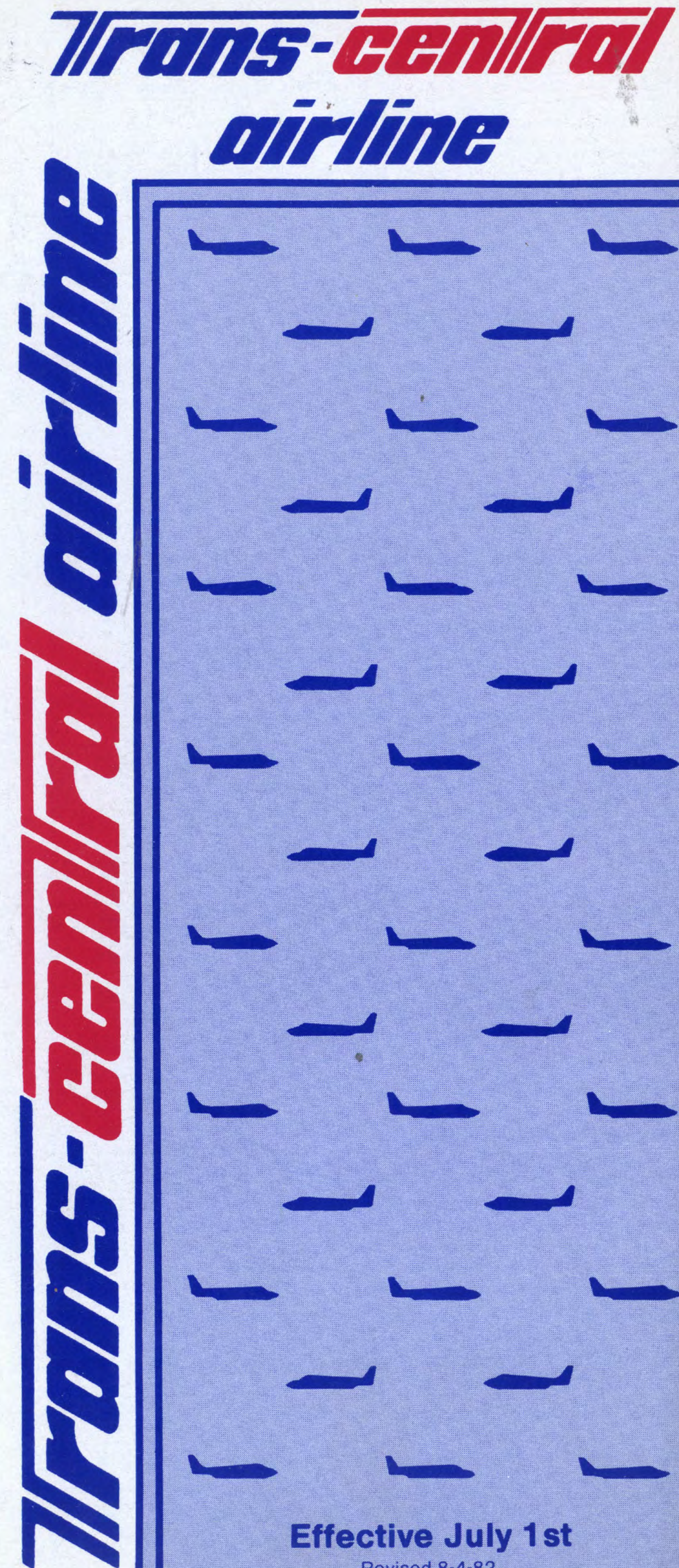
